ADDENDUM

The Country has been witnessing the Phase 2 of the Pandemic, with a sudden and substantial increase in the number of COVID-19 cases being reported and in the Union Territory of Dadra Nagar Haveli & Daman and Diu also, there has been a fresh surge in the number of cases since the past 15 days. Being a small UT located between Maharashtra and Gujarat, it is important to effectively contain the spread of COVID-19 by strict enforcement of the guidelines issued by this Administration and break the chain of transmission with a view to expeditiously restore complete normalcy.

Therefore, in continuation to the Order issued dated 25th March 2021 vide no Order No. DMHS/COVID-19/2020/324, the following measures shall be strictly enforced and complied with:

- The District Administration shall take strict and intensive measures to enforce COVID-19 appropriate behaviour. It is reiterated that Strict enforcement of wearing of face masks, and social distancing at all public/work places shall be ensured and any violation should be dealt with in a stringent manner in accordance with the Order No. DMHS/COVID-19/2020/416 dated 31.08.2020 & Order No. DMHS/COVID-19/2020/828 dated 20.11.2020 wherein the District Administration shall levy a fine/take penal actions as prescribed below by virtue of powers conferred under Disaster Management Act, 2005:

- Persons under Home Isolation and Home Quarantine shall be strictly monitored as per the protocols by the Incident commanders, with scrupulous monitoring by the Health Department.
- COVID-19 Vaccination shall be carried out on priority basis for potential categories of spreaders such as Vegetable vendors, shopkeepers, persons working in Salons/Hotels/Gymnasiums and other such target groups who may frequently come in contact with the general public. The Officials of District and Local Administration shall proactively mobilize these groups of people for vaccination in coordination with the Health Department in accordance with the guidelines issued by the MOHFW with respect to the eligible age group.
- The district Administration shall impose Night curfew between 08:00 PM to 06:00 AM, however the operation of essential and medical services, delivery of food items, Industrial workers commuting for shift duties are exempted from this.
