
**ADDENDUM**

In continuation to the Order No. DMHS/COVID-19/2020/324 dated 25<sup>th</sup> March, 2021 read with Addendum No. DMHS/COVID-19/2020/341 dated 5<sup>th</sup> April, 2021 issued by the UT Administration of Dadra & Nagar Haveli and Daman & Diu, owing to the increasing number of COVID positive cases everyday, the following additional restrictive measures are being imposed for the effective containment of COVID-19:

- Social / Cultural / Religious / Political and other public gatherings are prohibited in the territory. Marriage and funeral/last rites related gatherings are permitted with a maximum limit of 50 persons outside Containment Zones subject to strict observance of Social distancing, Mandatory wearing of face masks, provisions for thermal scanning and hand wash/sanitizers.
- Complete Curfew is hereby imposed on all weekends (Saturdays and Sundays) with effect from 17.04.2021, however the operation of essential and medical services, delivery of food items, Industrial workers commuting for shift duties are exempted from this.
- It is mandatory that all travellers coming from other States and International Travellers shall carry negative RTPCR report taken atleast before 72 hours. Industrial Labourers/Workers, vegetable vendors/shopkeepers, persons working at different Industrial/Commercial/Private/Government Establishments commuting on daily basis across the borders of the UT are exempted from this.
- It is reiterated that the SOPs issued for Gyms/Salons/Spas/Parlours and other such public places shall be strictly enforced and scrupulously followed.

The District and Local Administration shall ensure strict enforcement and compliance of the same.
