Subject- Your kind intervention to safe guard industries at this time.


Respected Sir,

- 6) The Govt. of India has announced payment of both side EPF contribution by Govt. for the those employers who employed up to 100 employees we appreciate the same by at the same time we request to please consider same facility to every employer irrespective to the number of employees
- 7) The appropriate authority may please consider reimbursing amount against payable salary and wages by employers as the employer himself are under financial trouble due to this lock down and such type of move will help employer to sustain in future.
