Industries are required to obtain above said permission for existing and new bore wells in their premises to extract groundwater through bore wells.

While online application is made to above said Authority, a certificate is required from the concerned Municipality / Village Panchayat that there is no arrangement / or inadequate arrangement through public water supply system.

Industries within the geographical jurisdiction of Panchayats are making individual applications to their respective Panchayats. These Panchayats process and issuing an individual certificate.

Instead, Federation suggests area wise common certificate to save time and procedural avoidable activities. This common certificate will certify whether in that area public water supply is available or not. If available, it will further certify whether it is sufficient.


