### INTRODUCTION OF "NEW INVESTMENT PROMOTION SCHEME-2022"

- The Administrator of UT- DNH has announced "The Investment Promotion Scheme-2022" for the Next Five Years and the same will be notified soon.
- Applicable for New and Existing Units Set up in Both UTs.
- Available over and above the central Government Subsidy
- The Key Highlights of the scheme is Described hereunder.

#### **SECTION - A:**

#### **SCHEMES FOR MSMEs**

#### **Applicability of Scheme**

New MSME Units

#### And

• Existing MSME Units: Subject to Expansion by 50% of Investment in Gross Fixed Asset(60% of Which in Plant and Machinery)

Commencement of Production during policy period

### SCHEME A- 1: CAPITAL INVESTMENT SUBSIDY

#### **Capital Subsidy**

- Available 15% of Project cost (Building+Machinery)
  - Max Rs. 15 lakhs to Micro;
  - Max Rs 30 lakhs to Small and
  - Max Rs 45 lakhs to Medium Industries.
- \* The First Generation Women and Differently Abled Entrepreneurs setting up new Micro / Small / Medium Enterprises shall be entitled to additional subsidy equivalent to 10% of GFCI subject to a maximum of Rs.15 lakhs



#### **SCHEME A-2:INTEREST SUBSIDY FOR MSME**

- (1) Manufacturing sector 50% of Interest paid upto Rs. 30 lakhs
- (2) **Service Sector**: 50% of Interest Paid upto Rs. 30 lakhs
- Additional 10% for women/differently abled OR start ups. Additional 10% to young entrepreneurs(All Partners/Directors below age 35)

#### **CAPITAL SUBSIDY: MAIN CONDITIONS**

- Available only after Commencement of Production.
- Continue Operation for at least Next 5 years.
- Subsidy available <u>Twice</u> during tenure of subsidy for the New/Existing Unit going for the expansion.
- Unit cannot claim under more than one scheme at a time.
- Availing Term loan from Bank or FI is compulsory.

#### **INTEREST SUBSIDY: MAIN CONDITION**

- Enterprise should Continue production for at least 5 years from start of Commercial production.
- The Enterprise should undertake that it has paid all government dues and have all valid statutory permission in place.
- The interest subsidy will be for 5 years from date of production.



### SCHEME A-3: ASSISTANCE FOR QUALITY CERTIFICATION

- 50% for National / International Certification
  - Certification from National / International Certification i.e. Bureau of Indian Standards (BIS), Indian Standards Institution (ISI), World Health Organization (WHO), Good Manufacturing Practice (GMP), Hallmark, etc. and other National / International Certification
- 50% for testing equipment and machinery for certification upto Rs.10 lakh.
- MSMEs acquiring the certificates from certifying bodies, registered with National Accreditation Board for Certification Bodies (NABCB) alone will be eligible to avail incentives under the Scheme



# SCHEME A-6: ASSISTANCE FOR PATENT REGISTRATION / TRADE MARK REGISTRATION

- 75% upto Rs.25 lakhs
  - 75% of the cost/expenditure incurred for any number of patent applications subject to Rs.25 lakhs per applicant / enterprise for obtaining Patent Registration / Trade Mark Registration of developed product / process during policy period.
- Attorney cost upto Rs. 50,000 for domestic and Rs. 2 Lakh for international patent with overall cap of 75% of cost of patent registration.
- Fees paid to patent attorney, patent service centre, patent registration and patent equipment purchased to develop Patent / Trade mark will be eligible as cost / expenditure (excluding travel & hotel charges).



### ASSISTANCE FOR ZED CERTIFICATION

- @ 50% of all charges upto Rs.1,00,000/- after deducting any incentive received from central Govt. of India.
- Existing or New Enterprise will be eligible.
- The enterprise shall have to apply within a year from the date of issue of the certificate.

# ASSISTANCE FOR SAVING IN CONSUMPTION OF ENERGY AND WATER

- 75% of total cost paid for Energy / Water Audit conducted by recognized Authority, upto Rs.1 lakhs.
- 25% for equipment recommended by Audit Authority upto Rs.20 lakhs.
- The assistance on cost of equipment will be eligible subject to the condition that saving in Energy / Water is reduced by a minimum of 20% of average monthly consumption of previous 12 months before audit



#### ASSISTANCE FOR ENTREPRENEURSHIP UNDER SKILL DEVELOPMENT

- The Scheme provides assistance to budding entrepreneurs and their staff /staff of the existing entrepreneurs to undergo Entrepreneurship / Management development training/Skill training from Reputed national level institutions certified by National Skill Development Corporation/State Skill Councils.
- upto Rs. 1.5 Lakh per course per person upto 20 persons per year/enterprise

# ASSISTANCE TO SMALL AND MEDIUM ENTERPRISES (SME) FOR RAISING OF CAPITAL THROUGH SME EXCHANGE

- For comoanies getting SME status as on the date of listing in SME Exchange
- 25% upto Rs.5 lakhs.



#### INCENTIVES FOR DOUBLING OF EXPORT VALUES.

- Doubles the value of exports over the previous year
- 1% of export value upto Rs.20 lakhs.
- For Women entrepreneur 2% upto Rs.30 lakhs

# REIMBURSEMENT OF FREE ON BOARD (FOB) EXPENSES.

 20% upto Rs.20 lakhs for 3 years for Food / Marine processed products.

# ASSISTANCE FOR CAPITAL INVESTMENT IN SOLAR POWER GENERATION

#### ASSISTANCE FOR PARTICIPATION IN INDUSTRIAL EXHIBITIONS ABROAD

- @ 25% of capital investment on Solar Generation upto Rs.50 lakhs subject to achieving 10% of Solar Power generation /Consumption.
- Applicable for captive consumption also

- 50% of Cost of Stall and marketing expense for participating in international exhibition, of upto Rs.2 lakhs for international exhibitions for
- 5 times for each unit during policy period



### INCENTIVE FOR LOCAL EMPLOYMENT

- Rs.3 lakhs per 20 local
   Persons upto Rs.15 Lakh to each eligible unit
- and Minimum period of employment shall be 1 year.

#### **AWARDS FOR MSMEs.**

- Award of Rs. 2 Lakhs, Trophy and Appreciation for growth, turnover, exports, certifications
- 3 years in the scheme period

#### **SECTION B:**

#### **SCHEMES FOR TEXTILES SECTOR**

#### **SCHEME FOR TEXTILE SECTOR**

- Applicable to all the Textile Sectors and Textile Machinery Manufacturing
- 60% of Interest paid upto Rs.60 lakhs per annum for 5 years for all types of textiles

and

• Additional 10% to Export oriented Carpet industry upto 70 lakhs.

### SCHEME C-1 : ASSISTANCE FOR FURNITURE SECTOR

- @ 20% of GFCI made in automation machineries, upto 50 lakhs
- Interest subsidy for furniture sector @ 60% of interest paid up-to Rs.50 lakhs per annum.
- The cost of establishment of showroom for display & sale will be reimbursed @ 20 % upto Rs.50 lakhs for and if on rent @ 25% of actual rent paid for 3 years, for a showroom with a minimum size of 2000 square feet.
- Power rate incentive of Re.1/- per unit for one year maximum upto Rs. 50 Lakhs from date of commencement of production.



#### SCHEME C-2:

# ASSISTANCE FOR MARBLE, IT & ITES, ELECTRIC VEHICLES & SPARE PARTS, TOY AND SEMI-CONDUCTOR INDUSTRIES SECTORS

- 20% of GFCI made upto Rs.50 lakhs for the units.
- 15% of GFCI made upto Rs.7.5 Cr. for large units in Semiconductors.
- Interest subsidy @60% upto Rs.50 lakhs per annum.

# SCHEME C-3: SCHEME FOR MEDICAL EQUIPMENT AND ACCESSORIES, MEDICAL DIAGNOSTICS AND AYUSH PRODUCTS MANUFACTURING UNITS

- Capital subsidy @ 20% of GFCI upto Rs.50 lakhs for the units.
- Interest subsidy @ 60% per annum upto Rs.50 lakhs per annum
- Avialable for 5 years Period

### SCHEME C-4: SCHEME FOR FOOD PROCESSING INDUSTRIES

• Interest subsidy @ 60% of interest paid upto Rs.50 lakhs per annum

and

• additional 10% subsidy for Food processing units established in dedicated food processing parks.

#### SCHEME-C-5: SCHEME FOR MARINE PRODUCTS PROCESSING UNITS

• Interest subsidy @ 60% of interest paid upto Rs.50 lakhs per annum

#### SCHEME C-6: SCHEME FOR VACCINE MANUFACTURING UNITS.

- Interest subsidy @ 70% of interest paid upto Rs.60 Lakhs per annum
- and Capital Subsidy @ 15% of Cost of Machinery Cost upto maximum of 10 Cr.

### GENERAL SCHEME FOR ALL SECTORS AND UNITS

#### GENERAL SCHEMES FOR ALL SECTORS

#### **SCHEME D-1:**

#### SCHEME FOR REIMBURSEMENT OF STAMP DUTY.

- 50% for Manufacturing MSME sector.
- 25% for manufacturing units other than MSMEs.
- 100% for the industrial complexes dedicated only to Thrust sectors and reimbursement after 25% of the infrastructure development
- Industrial units located in the industrial parks will be eligible for reimbursement of 50%.

### ENVIRONMENT PROTECTION INFRASTRUCTURE SUBSIDY

• Assistance upto Rs.30 lakhs @25% of capital cost for ZLD Facility and units producing alternatives to single use plastics.

### SCHEMES FOR HANDICRAFTS ARTISANS AND COTTAGE INDUSTRIES

#### ASSISTANCE FOR CAPITAL INVESTMENT FOR THE HANDLOOM AND HANDICRAFTS ARTISANS

- @ 50% for machinery upto Rs. 2 Lakh and @ 50% for working capital upto Rs. 2 Lakh. Additional 10% to SC/ST/Women/Differently Abled.
- 50% upto Rs. 5 lakhs for 5 years.

# ASSISTANCE TO UPLIFT THE ECONOMIC CONDITION OF ARTISANS/PERSONS

 Tools/equipment to SC/ST/OBC/EWS communities to generate adequate income and selfemployment for 27 professions such as hawkers, vegetable vendors, carpenters etc which is over and above the existing schemes



### SCHEMES FOR HANDICRAFTS ARTISANS AND COTTAGE INDUSTRIES

#### FINANCIAL ASSISTANCE TO COTTAGE INDUSTRIES

- Capital subsidy @25% of the term loan for Cottage Industry upto Rs. 5 Lakh and
- Interest Subsidy @ 50% of interest paid up to 5 lakhs per annum till five years.
- Additional 10% to SC/ST/Women/Differently Abled.
