ORDER

Whereas, to prevent injury to life and health of residents of Silvassa Municipal Council Area, it is necessary to contain COVID-19 Corona Virus epidemic.

Whereas, Section 231 of the Dadra and Nagar Haveli and Daman and Diu Municipal Council Regulation 2004 as amended from time to time casts a duty upon all residents of the Council who are suffering from any dangerous disease to not to willfully expose themselves, without proper precaution in any place of public resort.

Whereas, many cases of this disease remain asymptomatic--but infectious--causing further spread of the disease.

Whereas, following societies/buildings/complex/chawls were declared as containment zones on the dates mentioned against their names: -


Whereas, before decontaining these zones it is necessary to ascertain if any of the residents are exhibiting ILI symptoms, so that such individuals may be isolated and proper medical treatment could be given to them and spread of corona through them can be checked.

Therefore, I, Mohit Mishra, Chief Officer, Silvassa Municipal Council, in the exercise of powers vested in me in Dadra and Nagar Haveli and Daman and Diu Municipal Council Regulation 2004 as amended from time to time, read with Code of Criminal Procedure 1973 and Order No. ADM/LAW/62/2006/251 dated 22-02-21 do hereby order as under:

1. Teams as per Annexure-I shall conduct survey of ILI like cases in societies/buildings/complex/chawls mentioned against their names. They shall go door to door and find out if any of ILI symptoms like dry cough, fever, tiredness is being exhibited by any of the residents of these societies/buildings/complex/chawls.
2. All residents are directed to cooperate with the teams and exhibit themselves and their family members to the teams for ILI survey, they are also directed to state truth about the state of health of their family members.
3. Any person who does not cooperate with the teams, or who states false statement to the team about his/her health shall be prosecuted and penalized in accordance with applicable provisions of the Dadra and Nagar and Daman and Diu Municipal Council Regulations, 2004 as amended from time to time and any other applicable law.
4. Only after complete survey is done regarding current status of health of all members of societies/buildings/complex/chawls, an appropriate decision regarding reduction or expansion of containment zones shall be taken.
5. Hence all society members are directed to cooperate with the teams involved in conducting ILI survey in their respective societies/buildings/complex/chawls.

The team shall follow the hygiene protocols including washing of hands, wearing of mask, etc. and ensure individual safety at all times. They shall maintain social distancing and regularly sanitize their equipments, if any. Any person who has tested positive for Corona-Covid-19 virus or their family members or any other Home Quarantined/isolated family shall not be asked to come out of Quarantine/isolation.

As the order cannot be served individually, the order is being put in the public domain for information and necessary action.
