#### **ORDER**

Whereas, to prevent injury to the life and health of residents of Silvassa Municipal Council Area, it is necessary to contain the COVID-19 Corona Virus epidemic.

Whereas, Section 231 of the Dadra and Nagar Haveli and Daman and Diu Municipal Council Regulation 2004, as amended from time to time, casts a duty upon all residents of the Council who are suffering from any dangerous disease to not to willfully expose themselves without proper precaution in any place of public resort.

**Whereas,** many cases of this disease remain asymptomatic--but infectious--causing further spread of the disease.

Whereas, it is necessary to conduct Rapid Antigen Test Camps for employees, staff, workers, labours, security staff, etc. working in the industries premises.

**Whereas,** in this sequence, industries mentioned in Annexure-I have been selected as one of the lots to undergo Rapid Antigen Test.

Therefore, I, Mohit Mishra, Chief Officer, Silvassa Municipal Council, in the exercise of powers vested in me in Dadra and Nagar Haveli and Daman and Diu Municipal Council Regulation 2004, as amended from time to time, read with Code of Criminal Procedure 1973 and Notification No. ADM/LAW/62/2006/251 dated 22-02-2021 do hereby order as under:

 All employees, staff, workers, labours, security staff, etc. working in Industries mentioned in Annexure-I should get themselves mandatorily tested in Rapid Antigen Test Camps which shall be organized on 31-05-2021 and 01-06-2021 i.e Monday and Tuesday at Sahkar Bhavan, Near Dan Udhyog Shopping Centre, Opposite to Piparia Garden, Silvassa-Vapi Road, Piparia Silvassa, DNH from 9:30 am to 4:00 pm (1:00 pm to 2:00 pm lunchtime).

- No employees, staff, workers, labours, security staff, etc. who have either tested positive in these tests shall not be allowed to come in Industry/Company from dated.02-06-2021 i.e Wednesday onwards.
- 3. Even after testing, all social distancing measures, mask and sanitization protocols and other orders of the administration issued from time to time to contain the disease, shall have to be mandatorily and strictly followed by the concerned employees, staff, workers, labours, security staff, etc. tested under this order.

As the order cannot be served individually, the order is being put in the public domain for information and necessary action.
