In continuation of the previous communications we would further like to bring to your notice that, The Ministry of Housing and Urban Affairs vide its advisory dated 28th May 2020 have issued directives to various development authorities to suomoto extend the validities of all the N.O.C, Permissions etc. related to land development by a period of 9 months. The list of N.O.C and Permissions mentioned in the advisory are inexhaustible. And in line with the same, The administration has already granted the extension to construction permission upto 31st march 2021 which have lapsed on or after 25th march and we are thankful for the same.

Further, Industries had purchased N.A land for Brown field and Green field projects way back in 2018 but with the notification of Draft Ribbon Development Control Rules, Construction Permissions were kept in abeyance and application for the same were not accepted by the Authority for a period between 17/10/2018 to 21/10/2019 which resulted into lapse of N.A permission in many cases and also in some cases where construction permission was still subsisting, the Industries were unable to apply for extension of Construction

And thereafter with the outbreak of the pandemic covid-19 in the month of March-2020 all the economic activity have come to a sudden stand still. Even after the relaxation of lockdown, the general movement of the management has been curtailed and fresh N.A permission has not been applied for in many cases. Because of these unusual circumstances some of the industries opted out of DNH to other states as they had already placed order for the machinery.

Amidst the border tension with China and the call for Atma-Nirbhar Bharat by our Hon'ble Prime Minister, restrictions has been imposed on import from China. This has boosted the morale of Indian Industry. Manufacturers are looking forward towards augmenting the existing capacity by Brownfield and Greenfield projects in sectors which were largely dominated by imports from China and this has created a sudden demand for Industrial Land. DNH in close proximity to Mumbai the financial capital of India has all the potentials to attract such investment but unavailability of N. A land for reason explained above has become a major hindrance.
