## ORDER UNDER SECTION 144 OF THE CRIMINAL PROCEDURE CODE

WHEREAS, in the evening time, trucks and goods carriers, in large numbers, move out from nearby industries and start from 1) From Rakholi T. Point to Samarvarni Junction and 2) From Lions School to Samarvarni Junction and to Shahid Chawk and move towards the Athal Bridge to go to Gujarat and Maharashtra State:

AND WHEREAS, the ongoing road repairs on the stretch of road from Rakholi T. Point to Samarvarni Junction lead to traffic congestion during peak hours on that stretch;

AND WHEREAS, the ongoing construction work of the new bridge at Athal Bridge, created a bottleneck, and the movement of a large number of goods-carrying vehicles slowed down the general traffic flow and created traffic congestion;

AND WHEREAS, due to the continuous flow of vehicular traffic on the above-mentioned roads, it has become prone to road accidents which could endanger the lives of the people using it;

AND WHEREAS, a report has been received vide letter no. DNH&DD/Police/14/SP(T&I)/2024 Dated 17/01/2024, from the Superintendent of Police (Traffic), DNH, regarding easing traffic congestion in the city wherein it is suggested to impose ban/restriction on movement of trucks and goods carriers on the above-mentioned road stretches from 05:00 PM to 09:00 PM.

NOW THEREFORE, in view of the above and in the exercise of the powers conferred under Section 144 of the Code of Criminal Procedure Code, 1973, I, Priyank Kishore, District Magistrate, Dadra & Nagar Haveli, hereby impose a temporary ban/ restriction on the movement of trucks, goods vehicles and heavy goods vehicles on the following roads from 05:30 PM to 08:30 PM.

1. From Rakholi T. Point to Samarvarni Junction
