

"White Paper on Biomass"

Dear CBEII Members,

PwC, PricewaterhouseCoopers Private limited along with OPM, Oxford Policy Management Limited; with support from the Foreign, Commonwealth and Development Office (FCDO), Govt of UK have drafted a White Paper to put forward suggestions for strengthening the Biomass sector in India.

The White Paper also puts forward the value proposition in terms of carbon emission reduction potential and cost savings that can be achieved by replacing conventional fuels with biomass.
