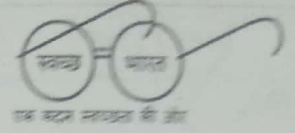



ORDER

In exercise of powers vested in me under bye-law no. 3.11 of Dadra and Nagar Haveli, Silvassa Municipal Council, Solid Waste (Handling and Management) Bye Laws, 2018, I, Chief Officer, Silvassa Municipal Council, do hereby declare that the following premises/people shall be considered to be Bulk Waste Generator in addition to definition of Bulk Waste Generator provided in Bye Law 3.11 Dadra and Nagar Haveli, Silvassa Municipal Council, Solid Waste (Handling and Management) Bye Laws, 2018. It is hereby declared, to all concerned, that Silvassa Municipal Council shall not collect, accept, process, or allow the waste generated by these bulk waste generators in dustbins maintained by Silvassa Municipal Council. These Bulk Waste Generators shall have to process their own waste from 30th July, 2018. In case it is found that they have not started processing their own waste by 30th July, 2018, these Bulk Waste Generators shall be punished and fined in accordance with Dadra and Nagar Haveli, Silvassa Municipal Council, Solid Waste(Handling and Management) Bye Laws, 2018 and also in accordance with Dadra and Nagar Haveli Municipal Council Regulation 2004; which may involve, in addition to prosecution in most serious cases, fine of Rs.1000/- per incidence and fine of Rs.10000/- per incidence for repeated offenders. The wet waste may either be composed or may be used to make biogas and the dry waste may be processed at the premises of Bulk Waste Generators as per Solid Waste Management rules 2016, or at some common processing site.

Following shall be treated as Bulk Waste Generator in Silvassa Municipal Council area:

Sr. No.	Categories (Bulk Waste Generator)
1	All Hotels having 20 rooms and above.
2	All Restaurants with 50 Seats and above.
3	All Societies with 100 flats and above.
4	All Industries whatever their size and nature.
5	All Construction and Demolition waste generators.
6	Educational Institutions with strength of 300 and above.
7	All Hostels with 20 rooms and above.
8	All places of Worship with Carpet area of 100 Sq. Mt. and above.
9	All Clubs, Gymkhanas, Marriage Halls.
10	All Sport Complexes.
11	Any other premise included in definition of Bulk Waste Generator as per the Bye Law no. 3.11
