
Sir,


At the outset, the Managing Director, OI DC welcomed the representatives present in the meeting.

The Managing Director, OI DC informed about the future proposed project by OI DC for construction of Industrial Workers Dormitories, 1 BHK flats and Industrial Facilitation Centre on land bearing Survey No. 261/P at Village Dadra.

Allotment of remaining 27 flats already constructed on land bearing Survey No. 261/P at Village Dadra was also discussed. The industrialists present in the meeting expressed their keen interest in taking over the available flats on outright sale basis. The industrialists were of the opinion that two separate blocks i.e. one for bachelor workers (Dormitory type houses) and another for workers with family (1BHK Type house) may be constructed. The industrialists have also shown their interest in taking over the flats on rental basis as well as outright sale basis.

The Managing Director, OI DC suggested for three type of residential blocks i.e. dormitory, 1 Room kitchen and 1 BHK houses. The industrialists were requested to give their requirement in writing to enable OI DC to decide on the housing scheme to be launched.

The meeting ended with vote of thanks to the chair.
