NOTIFICATION

In exercise of the powers conferred by Section 92 of the Dadra and Nagar Haveli Excise Regulation, 2012 and in partial modification of earlier Notifications as referred to in preamble (1) and (2) above, the Administrator of Dadra and Nagar Haveli do hereby prescribes One Time License Fee in respect of following category of licenses and also revise the Excise duty of Country Liquor as under:-


