- 2. At the outset, The Chairperson welcomed all the members from trade, and thanked them for attending the meeting. She apprised them that meeting has been organised to understand the difficulties/problems faced by trade related to ITC refund of Zero rated Supply of export goods, E –way Bill and other issues.
- 3. The members of Trade expressed their happiness and thanked the Commissioner for this initiative. The representatives of the trade informed that they are getting ITC export Refund regularly, in time and that there is no issue/ difficulty reported by any members regarding implementation of GST and everything is going on smoothly.

- 4. The Chairperson also informed that the taxpayers have been allotted to respective authorities i.e. Centre/UTs vide order No. 01/2018 dated 01.01.2018. The Taxpayers should file physical copy of RFD 01A along with requisite documents as prescribed to their Jurisdictional authority.
- 5. The Chairperson discussed the issue of Non- Filers and stated that some taxpayers are not filing GSTR- 3B and that the ratio of non filers has increased, she requested the trade associations/ bodies to inform those taxpayers who have nort filed GSTR-3B return to file the same in time without any further delay.
- 6. The Chairperson also asked about any difficulties being faced by the trade on implementation of E-Way Bill. The trade stated that they are aware of all the provisions of E-Way bill and currently no difficulty is being faced by them in this aspect. They also requested that there should be no time limit of E way bill in intra state movement of Goods and requested the Chairperson to make a reference to the Ministry regarding the same.
- 7. As there were no further issues to be discussed as Trade representatives have expressed their complete satisfaction with regard to Refund disbursal and other issues, the meeting concluded with vote of thanks to the chair.
