NOTICE

Sub: Installation and Functionalization of Effluent Treatment Plant by the trade effluent generating Industries in the UT of Dadra Nagar Haveli.

The Hon'ble Supreme Court had passed an order on 22.02.2017 in the matter of Paryavaran Suraksha Samiti V/s. Union of India (WP (C) No. 375/2012) with the direction that, all the trade effluent generating industrial units running without Effluent Treatment Plant (ETP) shall install Effluent Treatment Plant and make it operational within three months from the date of the order i.e. 22.02.2017 failing which the defaulting industries shall be closed down and their power/water supply shall be disconnected by the Pollution Control Committee.

In this regard, through Public Notice dated 05/04/2017 in the leading regional news papers of Hindi, Gujarati and English language, Pollution Control Committee had informed to all the concerned about the order of the Hon'ble Supreme Court and the industrial units operating without an operational ETP under the Water (Prevention and Control of Pollution) Act, 1974 to install and fully operationalize their ETP as per the norms prescribed by the CPCB, within three months from the date of the judgement order i.e. 22.02.2017.

Pollution Control Committee, DNH officers had started inspecting all the trade effluent generating industrial units established in the UT of Dadra Nagar Haveli for identifying environmental compliance status under the Water (Prevention and Control of Pollution) Act, 1974, since May, 2017.

And all the identified trade effluent generating industrial unit which are operational without any ETP or involved in any type of discharge of trade effluent were issued closure directions by disconnecting their power supply and those industrial units which are operating without operationalizing their ETP as per the norms prescribed by the CPCB were issued direction for necessary compliances within limited time period.

Hon'ble NGT in its order dated 03.08.2018 directed the PCC to update status of ETPs, STPs, and online effluent & emission monitoring data display in the UT of Dadra Nagar Haveli to the Monitoring Committee (Nodal Officer, CPCB and Representative of MoEF & CC) on monthly basis for ensuring compliance of all the directions of the Hon'ble Supreme Court order dated 22.02.2017.

Therefore, in exercise of Section 33-A of Water (Prevention and Control of Pollution) Act, 1974 Pollution Control Committee, Dadra Nagar Haveli hereby direct all the trade effluent generating industrial unit established in the UT of Dadra Nagar Haveli to maintain following compliance status:

- 1) Provide proper connection for the flow of trade effluent from source of generation to the inlet of the ETP and for treated effluent from the out let of the ETP to the place of its consumption/ reutilization.
- 2) ETP shall be provided with flow meter both at inlet & outlet.
- 3) A separated energy meter having AMR system shall be availed for analyzing power consumption by operation of the ETP.
- 4) Provide adequate facility for collection and storage of ETP sludge and other hazardous wastes in the industrial premises.
- 5) Bore well or any other source of raw water supply in the premises of the industry shall be provided with flow meter.
- 6) For drawing ground water, obtain No Objection Certificate (NOC) from the Central Ground Water Authority.
- 7) Maintain record of raw water consumption, waste water generation, energy consumption by ETP and hazardous & other waste generation on daily basis.

All the trade effluent generating industries shall submit monthly compliance report of the above direction before 5th day of the every next month on regular basis from the date of issue of this notice, failing which Pollution Control Committee will be constrained to initiate legal action, which may include disconnection of power supply & water supply of defaulting industrial unit without any further notice.
