In exercise of the powers conferred by Section 140 of the Goa, Daman and Diu Town & Country Planning Act, 1974 (Act 21 of 1975) as extended to the Union Territory of Dadra & Nagar Haveli vide Notification No. GSR-749(E) dated 30.10.1984 by Ministry of Home Affairs, Government of India and made applicable with effect from 01.12.1990 vide Notification No.ADM/LAW/ATP/108(7)/90 dated 29.11.1990 and all other powers enabling in that behalf, the Administrator of Dadra & Nagar Haveli is pleased to amend the Development Control Rules – 2014 (DCR-2014) and Development Control Rules (Amended), 2015 of Dadra & Nagar Haveli as under:

- 1. Short Title, Extent and Commencement: These rules shall be called as "Development Control Rules (Amended), 2016 of Dadra & Nagar Haveli" and shall be applicable to entire Planning area of UT of Dadra and Nagar Haveli. It shall come into force from the date of its publication in the Official Gazette of Dadra and Nagar Haveli
- Definitions of Terms and Expressions: The terms and expressions not defined in these rules shall have the same meaning as in the Goa, Daman and Diu Town and Country Planning Act, 1974 as extended to the Union Territory of Dadra & Nagar Haveli.

Note: For IT/BT/NT industries, the Maximum height permitted is 27m and no floor should be less than 2.8m in height. In case the building is constructed on stilt (parking), the stilt height will not be considered in the total height and will not be counted in FSI. The parking under the stilt will be in addition to parking provided under DCR standard. Height of the stilt should not be exceed 2.7m.
