In the GST regime transporter have to carry an E-way Bill when moving goods from one place to another (inter State movement). Since it is a new rule introduced under GST, it is necessary that all Consignors/ Consignee/transporters be sensitized regarding the new procedures.

Provisions of latest amendment vide notification no. 3/2018-central tax dated 23-01-2018 shall also be explained in detail.

- 4. The training seminar shall be followed by an exhaustive question and answer session for the benefit of member of trade.
