<u>Subject:-</u> Special Refund Fortnight to be organized from 31.05.2018 to 14.06.2018 by CGST & Central Excise

Attention of all the Trade/Taxpayers is invited that Central Board of Indirect Taxes & Customs (CBIC), New Delhi is observing "Special Refund Fortnight", from 31.05.2018 to 14.06.2018, wherein the CGST & Central Excise Commissionerate Daman will clear all pending GST Refund applications received on or before 30.04.2018.

- 2. As per Circular No. 17/17/2017-GST dated 15.11.2017 it is reiterated that due to non-availability of the Refund module on the common portal, the applications i.e. FORM GST RFD-01A is required to be filed on the common portal and print out of the said FORM shall be submitted before the jurisdictional proper officer along with all necessary documentary evidences as applicable which are prescribed in the said Circular. Mere ONLINE submission of the applications for Refund is not enough.
