O R D E R

WHEREAS reports have been received that due to the situation prevailing in the area of the following police stations, it is apprehended that the terrorist/anti-social elements may seek hideouts in the area of the said Police Stations/Outposts and there is every likelihood of breach of peace and disturbance of public tranquility and also there is grave danger to human life and safety and injury to public property on that account.

AND WHEREAS it is necessary that some checks should be put on landlord/Hotel/Guest house/Lodge/Chawl owners so that terrorist/anti-social elements in the guise of tenants/visitors/guests may not cause explosion, riots, shoot outs, affray etc. and that immediate action is necessary for the prevention of the same.

Now, therefore I, G.S. Rajawat, District Magistrate, Dadra and Nagar Haveli in exercise of the powers conferred upon me by **Section 144 of Code of Criminal procedure, 1973** (No. 2 of 1974) do hereby order that

Landlord/Hotel/Guest house/ Lodge/Chawl owners shall let/sublet/rent out any accommodation to any person unless and until he has obtained the copy of any reasonable documents of identity proof (like Election I.D. Card, PAN Card, Driving License, Credit Card or Debit Card and any other reasonable proof of identity) of the said tenants/visitors/guests which falls under the jurisdiction of the area of the Police Stations/Out Posts as specified above in this order and unless and until he has furnished the particulars of the said tenants/visitors/guests to the In-charge of the Police Station/Outpost concerned.



All persons who intend to take accommodation on rent shall inform in writing in this regard to In-charge Police Station/Outpost concerned in whose jurisdiction the premises fall. The person dealing in the property business shall also inform in writing to the In-charge Police Station concerned in whose jurisdiction the premises fall about the particulars of the said tenants

This order shall come into force with the immediate effect from **22.08.2015** upto **20.10.2015** and shall be effective for a period of **60 days** (both days inclusive) unless withdrawn earlier.

Any person contravening this order shall be punishable under Section 188 of the Indian Penal Code.
