CIRCULAR

The Election to the seat of Lok Sabha to Dadra and Nagar Haveli Parliamentary Constituency is scheduled to be held on 23/04/2019 (Tuesday).

In view of above, the Election Commission of India has directed that in conformity with the provisions of Section 135B of the Representation of the People Act, 1951, the following directions are hereby ordered

- Every person employed in any business trade, industrial undertaking or any other establishment and entitled to vote at election to the House of the People shall or the Legislative Assembly of a State on 23/04/2019 (Tuesday) be granted a holiday.
- 2. No deduction or abatement of the wages of any such person shall be made on account of a holiday having been granted on 23/04/2019 (Tuesday) and if such person is employed on the basis that he would not ordinarily receive wages for such a day, he shall nonetheless be paid for such day the wages he would have been drawn had not a holiday been granted to him on that day.

The above directions require that all establishments and shops including those which work on shift basis shall be closed on the 23/04/2019 (Tuesday) in the Parliamentary Constituency Dadra and Nagar Haveli

Further, it is directed that casual workers working in the U.T. of Dadra & Nagar Haveli Parliamentary Constituency shall be given paid holiday as mentioned above on the day of poll of the concerned Constituency where he/she is a registered elector in consonance with the letter dated 11.03.2019 of the Election Commission of India and also its motto "No Voter to be/left behind".
