- 1) The Silvassa Municipal Council and Dadra and Nagar Havaeli Planning and Development Authority (DNHPDA) shall not issue Occupancy Certificate unless Building Contractors, Establishment, Employees etc has paid the Labour Cess and evidence to this effect shall have to be produced. A suitable condition shall be imposed in the construction permission that no Occupancy Certificate shall be granted unless the Labour Cess is paid to the account of Dadra and Nagar Haveli Building and other construction Workers' welfare Board.
- 2) The Silvassa Municipal Council and Dadra and Nagar Havaeli Planning and Development Authority (DNHPDA) shall put a condition in the construction permission order ensuring registration of the builder/contractor and the construction workers working at the construction site. The builders/contractors shall submit their list of workers engaged by them to the Labour Dept., DNH. If any change occurs during the construction period at any point of time, no builder/contractor shall engage construction workers to his work site or work place who is not registered with the Dadra and Nagar Haveli building and other construction workers' welfare Board.
- 3) The undertaking as per Section 12 on Rs. 100/- Stamp Paper submit by owner/developer of the land.
