Whereas the Silvassa Industries Association had filed an Application for Stay of levy of additional FPPCA pertaining to period between April 2012 to March 2015.

And whereas the matter was last heard on 22.12.2015 wherein the respondent DNHPDCL had submitted that they will not recover the additional FPPCA on the consumption for the period from April, 2012 to March, 2015 in accordance with the interim order dated 15.12.2015 till the final disposal of the Petition.

And whereas the Petitioner has filed an Interim Application stating that the respondent has, in violation to the Commission Order, has levied additional FPPCA with respect to the period between April 2012 to March 2015 @ 41 paise per unit under a different head namely "FPPCA charge for HT".

Now therefore, the Commission directs both the parties to appear before the Commission for hearing in person or through an authorized representative duly instructed and able to answer all the issues pertaining to the Petition on 19.02.2016 at Silvassa immediately after the Public Hearing on 19.02.2016 at Silvassa.
