

It is hereby brought to the notice of the **general public of Dadra & Nagar Haveli** about the provision of Section 143 of the Dadra & Nagar Haveli Land Revenue Administration Regulation, 1971, under which the Talathi shall enter in a register of mutations every report made to him under Section 142 by any person acquiring any right on any land or under Section 147, any intimation of acquisition or transfer received from sub-register office through the software 'BHOOPANJIKARAN' or in writing.

Hence the Mamlatdar and Talati **shall proceed for initiation of mutation process under relevant** sections of Dadra & Nagar Haveli Land Revenue Administration Regulation, 1971, immediately after receiving the intimation regarding any acquiring rights by any person by succession, survivorship, inheritance, partition, purchase, mortgage, etc.



NOTICE

Section 42 of Dadra and Nagar Haveli Land Revenue Administration Regulation 1971 provides for procedure for conversion of use of land from one purpose to another and Sub-Section 7 of Section 42 of the said Act provides for grant of Sanad to the holder in the prescribed form under the rules informing the decision of Collector permitting the applicant to use the said land for non-agricultural purpose.

It is hereby brought to the notice of **public in general and officials of PDA and SMC** granting construction permission on the basis of order from the Collector in particular that **the Sanad issued by Collector under Rule 50 of Dadra and Nagar Haveli Land Revenue Administration Regulation 1971 in Form VIII is the only necessary and sufficient document for all official purposes** intimating the Collector's decision of permitting non-agricultural use permission which is issued after payment of necessary fees by the applicant to the concerned authorities. The mutation in land records shall be done only after issuance of Sanad.
