Sub:- Refund of Security Deposit and furnishing of the Bank Guarantee in prescribed format

Hon'ble Sir,

We would like to state that, we have already submitted our representation in respect of issue of refund of our security deposit laying with Department. But till date our security deposit laying with the department is not refunded. Sir, as you know that many of our industries colleagues have surrendered their power connection and have settled their power bill and after recovering outstanding, department has permanently disconnected the power supply. When the consumer approach to DNHPDCL for refund, the refund is refused under the pretext that it is laying with Electricity Department.

Sir, almost more than one year has been completed on formation of DNHPDCL. We failed to understand, why till date the deposit is laying with the Electricity Department. At the time of formation of DNHPDCL entire assets and liabilities were transferred to DNHPDCL by the department but still we are struggling to get the refund of our security deposit.

Your goodself is hereby requested to look into the matter and ensure that the security deposit are refunded at the earliest and as per provision of Supply Code of JERC.

With respect to bank guarantee, it is very shocking that DNHPDCL is insisting to furnish bank guarantee with the provision of auto renewal

clause in the bank guarantee. The power supply to one of our industry has been disconnected by DNHPDCL. Under the pretext of bank guarantee without auto renewal clause. This is unfair, illegal and against the provision of Supply Code. It is understood that in some of the bank they are incorporating the auto renewal clause but in many banks the bank guarantee are issued for specific time limit. For the security of public/government money, the licensee DNHPDCL obtain the bank guarantee from consumers. This is to safeguard the risk and cover the security of DNHPDCL against the recovery of any outstanding dues from the consumer.

So for the safety, DNHPDCL can accept the Bank Guarantee and can insist the renewed Bank Guarantee from the consumer before the date of expiry of existing bank guarantee.


Sir, we are sure that, you honour will call upon DNHPDCL and after going through the provisions and legal status, instruct suitably to DNHPDCL in the interest of consumer as per provision of Supply Code.

We had represented to your kind honor the issue of replacement of CTPT; in case of its failure, in prescribed time limit as mentioned in SOP by our representation. In this regard the meeting was also held with DNHPDCL but till date no clarity has been given to the consumer. So, you are requested to issue an order clarifying the procedure and time limit by which the burnt CTPT shall be replaced by authority.
