

ORDER

Digital India Land records Modernization Programme (DILRMP) to streamline & digitize land records has been going on in the Territory of Dadra and Nagar Haveli. The agency entrusted to complete the Survey/resurvey has completed the survey in 72 villages. As the next step in the process, the survey report needs to be compared/ mapped with existing records, mismatches needs to be resolved, draft 7X12 extracts needs to be published and objections invited are to be resolved before the new survey is promulgated.


The procedure for promulgation is similar to the one adopted by Govt. of Gujarat and in accordance with Section 73 & 77 of the Dadra and Nagar Haveli Land Revenue Administration Regulation, 1971.

Therefore, the concerned Resident Deputy Collector within his/her jurisdiction is hereby delegated the power to approve the proposal for Promulgation of survey report of remaining villages of Dadra and Nagar Haveli and also to issue Promulgation order of remaining villages of Dadra and Nagar Haveli, as per promulgation process adopted by the U.T. Administration of Dadra and Nagar Haveli.

The role of Revenue Department in the Promulgation Process is specified and approved on file bearing No.SRV/NLRMP/Survey/Promulgation/2016 in detail.

This order shall take immediate effect.
