## **1. Background of Industries in the U.T.**

The U.T of DNH&DD is a manufacturing hub and the majority of the workforce is predominantly in the manufacturing sector. There are approximately 7100 Industries in the U.T of DNH&DD and major industries are Plastic, Pharmaceuticals, Paper and Paper products, Texturizing units, Rubber Plastic, Petrol Products based and Ice block making in Daman; Textiles, Plastics and plastic products are the major sectors followed by paper and paper products, packaging, Capital goods and basic metals in Dadra & Nagar Haveli.
