
Also in case of any emergency it become unreachable to hospital from their workplace or home and even it is not possible for fire tenders to reach in case of emergencies.



Considering this, serious traffic issue your good self is hereby requested to depute senior person of your department to ensure smooth movement of traffic in peak hours.


